NOTICE OF PUBLIC HEARING

On the **ENVIRONMENTAL IMPACT STATEMENT** of the **2X335MW COAL-FIRED POWER PLANT PROJECT** of the Proponent **GLOBAL LUZON ENERGY DEVELOPMENT CORPORATION**, to be located in Barangays Carisquis and Nalvo Sur in the Municipality of Luna in the Province of La Union.

Notice is hereby given to all parties who wish to give their opinion regarding the Environmental Impact Assessment (EIA) Report of the proposed **2 x 335 MW COAL-FIRED POWER PLANT** to attend the Public Hearing on **05 DECEMBER 2017 (TUESDAY)** at the **LUNA SPORTS COMPLEX, BRGY. ALCALA, LUNA LA UNION**. The onsite registration shall start at 8:00 am and the Public Hearing proper will start at 9:00 am.

The public hearing aims to achieve efficient exchange of information and views between and among project proponent, the DENR-EMB, relevant agencies, LGUs and other stakeholders on the environmental impacts of the proposed project currently applying for an Environmental Compliance Certificate (ECC).

Global Luzon Energy Development Corporation is proposing to develop the **2 x 335 MW COAL-FIRED POWER PLANT PROJECT** which aims to address the country's growing energy requirements.
