I. Attendance of stakeholders & the general public¹

The public hearing was held on March 22, 2019. There were 234 participants who attended the said meeting. Barangay *tanods*, barangay *kagawads*, barangay health worker and residents were present. Representatives of Mabuhay FilCement Inc. also attended, together with representatives from EMB and PCEAS. Attendance is attached as Annex A.

II. What and how the information was disseminated to various stakeholder groups

Invitations were sent to officials and residents of Brgy. Lumbang Calzada which stated that the public hearing was scheduled on 22 March 2019 (Friday) at 10:00AM in Brgy. Lumbang Calzada, Basketball Court, Calaca Batangas. See attached invites in Annex B. The registration for the said hearing started from 9:00AM until 10:00AM. The program officially started on 10:00AM with the national anthem, invocation from the head of Barangay Health Workers, Mr. Michael Gonzales and opening remarks from Mr. Carlo Enrique Soriano, the Municipal Planning and Development Coordinator.

Mr. Carl Louie Santiago, from the EMB Central Office, then introduced the conduct of the public hearing. He also presented the target objectives and outcomes. After that, a representative from Mabuhay FilCement Inc. presented the project background, description, location, implementation, schedule, and other information and facts regarding the MFI Grinding and Packing Facility.

The results of the EIS study conducted was discussed by Ms. Socorro Patindol. Afterwards Atty. Aime Rodaje presented the house rules on the conduct of public hearing. The open forum lasted for an hour then there was a break. After a two hour break, Atty. Rodaje discussed the agreements in the public hearing and consultation open forum and he also presented the summary of issues, concerns, and impacts raised by the public and responses of the proponent. Mr. Santiago then discussed the next steps in the EIA process and closed the program.
