On the ENVIRONMENTAL PERFORMANCE REPORT AND MANAGEMENT PLAN (EPRMP) of the proposed ADDITIONAL FINISH MILL (MILL 6) PROJECT of the REPUBLIC CEMENT & BUILDING MATERIALS, INC. (RCBM) located in BRGY. MINUYAN, MUNICIPALITY OF NORZAGARAY, PROVINCE OF BULACAN.

Notice is hereby given to all parties who wish to give their opinion regarding the implementation of the proposed ADDITIONAL FINISH MILL (MILL 6) PROJECT to attend a Public Hearing on 20 SEPTEMBER 2019 (FRIDAY) at 1:00 PM (registration starts at 12:00 noon) to be held in the COVERED COURT BESIDE BARANGAY HALL OF MINUYAN, MUNICIPALITY OF NORZAGARAY, PROVINCE OF BULACAN.

The Public Hearing is being conducted in connection with RCBM's application for the amendment of its Environmental Compliance Certificate (ECC). The EPRMP of the aforementioned project is being reviewed by the Environmental Management Bureau (EMB) of the Department of Environment and Natural Resources (DENR).

RCBM is primarily engaged in the manufacture, development and sale of cement, marble and all other kinds and classes of building materials, and the processing or manufacture of materials for industrial or commercial purposes. The Bulacan Plant is a cement manufacturing plant that uses the dry process. Its operation is covered by an ECC with reference no. 9409-0060105C issued by EMB Central Office on July 03 1996.
