Project Rationale	One Sky Aluminum Extrusion Corp. seeks to provide an environment-friendly and sustainable supply of aluminum products to cater to this growing demand. The project's end goals are to mainly support the Philippines towards becoming self-sufficient in the production of high-quality aluminum products and eventually enter the huge US market through Philippine-made aluminum products exportation. This will help significantly reduce or even possibly eliminate the country's reliance on importation while ensuring competitive pricing in both local and international markets.	
	The facility will generate jobs in its operations, maintenance, administration, and management. By increasing employment, the project will boost the purchasing power of the local population, stimulate local companies, and contribute to Pampanga's overall economic health. The local government of San Simon and Pampanga shall also benefit from supplementary taxes. The construction of the project shall also support the national industrial development program and can reduce the country's dependency to imported aluminum products. The facility shall support the sustainable development agenda and	
	the circular economy as the project will recycle scrap aluminum into high-quality aluminum products.
