Subject: **Non-requirement of barangay and/or local government unit
Endorsements and locational clearances for CNC Applications**

Consistent with the Department's thrust to further streamline and standardize the procedures and requirements of the Environmental Impact Statement System, we would like to reiterate that barangay and/or local government unit endorsements and locational clearances are no longer required in processing Certificate of Non-Coverage (CNC) applications. Please refer to the attached partial listings of economic activities covered by CNC and the checklist of requirements for CNC application.

All concerned are enjoined to comply with this Order which shall take effect immediately.

ADDITIONAL LISTING OF PROJECTS NOT COVERED BY THE EIS SYSTEM

- 1. Facilities for service Industries¹ that does not emit pollutants except for domestic/solid wastes² and occupying a space equal to or less than 2,500 sq.m. in urban areas and 1 hectare in urban areas**
 - Examples of this includes Information Technology Services, Vehicle Emission Testing Centers, Consultancy Services, Banks, Lending Institutions, Telecommunication and Broadcasting Towers³, Trading Business and similar facilities
- 2. Facilities for Barangay Micro-business Enterprises⁴ (BMBE) projects or projects with less than 3M capitalization involving only assembly of components, molding, sculpturing, cutting, sewing, knitting, weaving, briquetting and carpentry works;**
- 3. Transportation services⁵ including garage or terminals (without service facilities) equal to or less than 5,000 sq. m.**
- 4. Importation / purchase of equipment⁶**
- 5. Department Stores which sells only non-perishable goods and Showrooms for motor vehicles and similar products without canteen or food stalls;**
- 6. Cutflower Industry Projects**
- 7. Environmental enhancement / improvement projects such as tree planting projects in forests or sloping areas (regardless of the size);**
